CONTRACT INFORMATION

On the date of _____, the buyer and seller have entered into a legally binding agreement for the sale of DOG- _____, matching exactly to the description above, and verified by both parties.

When paying on the date of pickup, the buyer will need to pay with cash, money order or cashier's check. No personal checks accepted unless paid 10 days in advance of pickup date.

SPECIAL WARRANTIES

Limited Registration Policy:

All dogs are sold on LIMITED REGISTRATION.

The Seller agrees, by this contract, to lift the limited registration once this criteria is met:

The dog must pass OFA (when older than 24 months) or the SV hip certification program with a fair or better, and documentation presented to Seller.

Once this criteria is met, the limited registration will be upgraded to full registration at which point you may breed the dog. No registration will be changed prior to 24months, or 2 years of age.

.The buyer agrees further that ALL SPECIAL WARRANTIES shall be considered null and void in the event that the dog was bred before 2 years of age.

Any other arrangements must be made with the Seller's WRITTEN CONSENT.

Breeder Agrees:

- 1) Above dog/puppy has been found to be in good health.
- 2) Above dog/puppy is up to date on its immunizations and wormed.
- 3) To supply buyer with shot record, registration information or AKC papers (if received on time) or receipt, and any other necessary paperwork at time of purchase.

72 Hour Health Guarantee:

This puppy is guaranteed to be in good health at the time of delivery. For the protection of the buyer and seller, the puppy is required to be examined by a licensed veterinarian within 72hrs of delivery to purchaser. If the puppy is declared to be in unacceptable health by the licensed veterinarian within 72 hours (unless this falls on a weekend or Monday is a holiday) of the purchase/shipment date, examining Veterinarian shall issue a written statement of diagnosis that must be presented at the time the puppy is returned. The puppy must be returned to Seller within 5 days of purchase date. If the Buyer does not take the puppy to a veterinarian within 72 hours from the date of purchase, this warranty becomes null and void.

Up to and including the date of delivery, the puppy (aka DOG) has received proper vaccinations and de-worming. The buyer has been informed a received a copy of when these were administered and what brand/mfg. was used, along with when future vaccinations and de-worming due.

- Puppy must be paid in full before being shipped or at the time of pick up.
- All deposits are NON-REFUNDABLE.

IF there is a problem, you the Purchaser understand and agree that the Seller DOES NOT refund money; Seller will replace the dog/puppy with one of equal value from the same litter, if available, or from another litter, only if our veterinarian is in agreement with the diagnosis of your veterinarian. If the dog/puppy is not examined by a licensed veterinarian as outlined above, no guarantee is given, and any implied guarantee is void.

BUYER AGREES:

- 1) To have above puppy vet checked within 72 hours of possession.
- 2) That all vet bills, upon receipt of puppy, are the responsibility of the buyer.
- 3) To keep the above puppy up to date on all immunizations and health care.
- 4) To notify the Seller if they can no longer care for the puppy for any reason. The Buyer agrees to then immediately contact the Seller and return the puppy/Dog. No refund of the purchase price will be made. The Buyer agrees to transfer full ownership and registration of puppy to Seller and provide a copy of veterinary records to date.
- 5) Breeder is not responsible for any transportation costs incurred in returning or replacing the puppy. This contract applies to the original buyer only and is non-transferable to a second party. This contract is null and void if any of the terms and conditions are not fulfilled.

No refund, in part or in full will be given for the following: There are certain disorders that may be caused by environmental factors for which the Seller/Breeder has no control over, for example: Coccidia, Kennel cough, Cancer, Demodectic Mange, Scabies, growths, allergies and other autoimmune system disorders are not covered in this guarantee. Coccidia and Kennel Cough are as common to dogs as colds are to children, they are easily treated infections. Neither are life-threatening and with treatment resolve within a short time. Kennel Cough is like a common cold and must run its course. This guarantee does not include uneven bites, un-dropped testicles or umbilical hernia.

This contract applies to the original buyer only and is non-transferable to a second party.

This contract is null and void if any of the terms and conditions is not fulfilled. All items covered under this guarantee are replacement only. We do not give refunds.
